# **Ratifying the Constitution**

Congress convened a Constitutional Convention in May 1787. Delegates from all the states except Rhode Island gathered to work on the new U.S. Constitution. The delegates were challenged with finding a balance between large and small states, between northern and southern interests, and between those who wanted a strong national government and those who were in favor of more states' rights.

The delegates approved the Constitution in September of 1787. It was then sent to Congress with an order that it be sent to the state legislatures for approval by their own conventions of delegates. Nine states needed to approve, or ratify, the Constitution before it would go into effect. After this total was reached, the government declared the Constitution in effect on March 4, 1789.
